MINIMUM ESSENTIAL EXPERIENCE:

Minimum MBBS with completed internship and registration with Medical Council of India. Prefer will be given to candidates processing Diploma in Industrial Medicine or Certificate of Training in Industrial Health of Minimum 03 months duration.

EMOLUMENTS & OTHER CONDITIONS:

- Engagement is full time, temporary and on contract basis and will have initial period of engagement for not more than one year based on the performance, period of engagement may be extended further on yearly basis. However, the maximum period of contract engagement should not exceed 03 years. Increment will be given on extension of services after completion of one-year engagement.
- 3. Consolidated Monthly fee of Rs 93,000/- (Ninety Three Thousand) will be paid per month.
- 4. Annual increment of Rs.2800/- will be given on extension of contract (if any) after completion of one-year engagement.
- 5. Apart from above remuneration, Company also provides unfurnished residential accommodation at GAIL Township (subject to availability and recovery of LFR, Electricity, water charges and any other charges as applicable).
- 6. Personal accident insurance policy shall be arranged for an amount of Rs.12 lakhs to cover any eventuality including disability and medical treatment therefor.
- 7. Family Floater Insurance cover of Rs. 5 Lakhs for indoor treatment is provided in respect of self, spouse and two immediate dependents i.e. children and/ or parents.

- 10. 12 Casual leave (CL) and 12 Paid Leave will be provided in a calendar year on pro-rata basis i.e 01 CL and 01 Paid leave for a month may be taken. Compensatory off will be provided for attending extra duty. Paid leave can be accumulated or carried within the contract period but not casual leave. Female Medical Consultants will also be entitled to Maternity Benefits as per the provisions of Maternity Benefit Act, 1961.
