



Vedanta Aluminium, GAIL in pact for gas supply



New Delhi: Vedanta Aluminium said it has entered into a pact with State-owned gas utility GAIL (India) Ltd for supply of natural gas to its smelter at Jharsuguda in Odisha. This transition, likely to be operational by the end of next year, will reduce emissions by an estimated 47,292 tonnes of CO₂ equivalent annually. PTI







SECTORS IN OVERDRIVE, SOME STUCK IN NEUTRAL

Q2FY25 corporate earnings reveal sharp contrasts across sectors, and some accelerating while others sputtering. Four of the 10 largest sectors — oil & gas, automotive, power, and FMCG — saw year—on—year profit declines, while six sectors posted double—digit earnings growth. Construction and infrastructure led the pack with 34.1% rise, followed by pharmaceuticals, auto ancillaries, metals, BFSI, and IT software. However, growth was uneven, with several sectors, including metals, oil & gas, and automotive, facing slowdown. Despite these challenges, BFSI, construction and infrastructure stood out, driving 58.2% of sectoral earnings in the quarter. KRISHNA KANT & RAM PRASAD SAHU steer through the dynamics

- ▶ Oil and gas companies were among the biggest laggards in the second quarter (Q2) of 2024-25 (FY25), with a sharp decline in earnings and flat to low-singledigit growth in net sales
- ► The combined net profit of oil and gas companies, including Reliance Industries (RIL), dropped 41.1 per cent Y-o-Y in Q2FY25, while their net sales grew by just 1 per cent Y-o-Y
- ▶ RIL's earnings were adversely



affected by a poor performance in its oil-to-chemicals and retail business, while its telecommunications division outperformed



- with double-digit growth in revenue and segment profit
- ▶ Public sector oil and gas companies such as 0il and Natural Gas Corporation, Indian0il, and Bharat Petroleum were hit by lower oil prices and a decline in refining margins
- Gas companies' earnings were impacted by a decline in operating margins, despite a recovery in volume growth

Vedanta Aluminium signs pact with GAIL for supply of natural gas

Vedanta Aluminium on Wednesday said it has entered into a pact with state-owned gas utility GAIL (India) Ltd for supply of natural gas to its smelter at Jharsuguda in Odisha.

The country's leading aluminium producer has entered into gas sales agreement with GAIL Gas Ltd, a subsidiary of GAIL (India) Ltd.

This transition to natural gas, likely to be operational by the end of next year, will lower the carbon footprint, reduce emissions by an




estimated 47,292 tonnes of CO2 equivalent annually, Vedanta Aluminium said in a statement. Vedanta is committed to achieving net zero emissions by 2050, by implementing a dual strategy that includes increasing renewable energy usage while also creating carbon sinks through afforestation efforts, it said. "Our partnership with GAIL Gas Ltd is a testament to our commitment reducing carbon and emissions embracing cleaner energy solutions," Priya Agarwal Hebbar, Nonexecutive Director at Vedanta and Chairperson Hindustan Zinc Ltd, said.

GAIL Gas Ltd will set up a 7.5-km pipeline to supply approximately 32,000 standard cubic metres of natural gas per day, with a five-year contract term starting upon pipeline commissioning. This cleaner energy alternative is expected to help Vedanta A l u m i n i u m 's commitment to a clean energy transition across its operations.

"This agreement is in line with our efforts to reduce carbon emissions and enhance our production capabilities, contributing to India's growing demand for aluminium in critical sectors," Sunil Gupta, Chief Operating Officer, Vedanta Aluminium said.

Vedanta Aluminium produced 2.37 million tonnes of aluminium in FY24.





वेदांता ने गेल के साथ किया करार

एल्युमीनियम वेदांता सार्वजनिक क्षेत्र की गैस कंपनी गेल (इंडिया) लि. के साथ समझौता किया है। यह समझौता कंपनी के ओडशा में झारसगुड़ा स्थित स्मेलटर इकाई के लिए प्राकृतिक गैस की आपूर्ति को लेकर है। देश की प्रमुख एल्युमीनियम उत्पादक कंपनी ने गेल (इंडिया) लि. की अनुषंगी कंपनी गेल गैस लि. के साथ गैस बिक्री समझौता किया है। वेदांता एल्युमीनियम ने बधवार को बयान में कहा कि प्राकृतिक गैस में यह बदलाव अगले साल के अंत तक चालू होने की संभावना है। इससे कार्बन उत्सर्जन में सालाना लगभग 47,292 टन की कमी आने का अनुमान है। बयान के अनुसार, वेदांता दोहरी रणनीति लागू कस्के 2050 तक शुद्ध रूप से शुन्य कार्बन उत्सर्जन हासिल करने के लिए प्रतिबद्ध है। इस दोहरी रणनीति में नवीकरणीय ऊर्जा के



उपयोग को बढाना और वनीकरण प्रयासों के माध्यम से कार्बन सिंक बनाना यानी कार्बन का अवशोषण करना शामिल है। वेदांता की गैर-कार्यकारी निदेशक और हिंदस्तान जिंक लि. की चेयरपर्सन प्रिया अग्रवाल हेब्बार ने कहा, गेल गैस लि. के साथ हमारी साझेदारी कार्बन उत्सर्जन को कम करने और स्वच्छ ऊर्जा समाधान अपनाने की हमारी प्रतिबद्धता का प्रमाण है। गेल गैस लिमिटेड प्रति दिन लगभग 32,000 मानक घन मीटर प्राकृतिक गैस की आपूर्ति के लिए 7.5 किलोमीटर लंबी पाइपलाइन स्थापित करेगी। इसकी अनुबंध अवधि पाइपलाइन चालू होने पर पांच साल की होगी।
