गेल ने आपातकालीन नंबर किए जारी

रविवार को गैस लीकेज होने से लोगों ने उठाई थी परेशानी

मेरठ। शहर में विभिन्न स्थानों पर गेल गैस की पाइपलाइन में लीकेज से लोगों को हुई परेशानी के बाद सोमवार को कंपनी ने आपातकालीन नंबर भी जारी किए गए। गेल गैस के मुख्य महाप्रबंधक विनय कुमार ने बताया कि गेल गैस की ओर से नेटवर्क बढ़ाने के लिए शनिवार रात 10 बजे से रविवार दोपहर 12 तक शटडाउन लिया गया था। इसकी सूचना सीएनजी स्टेशनों, औद्योगिक व व्यावसायिक कनेक्शनधारकों को दी गई थी।

तकनीकी कारणों के कारण रविवार को दोपहर ढाई बजे तक शटडाउन रहा।

इसके बाद गैस आपूर्ति बहाल कर दी गई। इस दौरान अधिकांश घरेलू गैस उपभोक्ताओं के घर के बाहर लगे गैस रेगुलेटर ट्रिप हो गए थे, जिनको ट्रिपिंग के बाद सरल प्रक्रिया से रिसेट करना होता है। जिन्हें यह प्रक्रिया आती थी, उन्होंने कर लिया बाकी को परेशानी हुई। इन्हें टेक्नीशियन ने रेगुलेटर को रिसेट कर निस्तारण किया। उन्होंने बताया कि रविवार को कई स्थानों से गैस दुर्घट की शिकायतें आईं।

अब फोन पर लें गेल गैस का बिल, करें भुगतान

गेल गैस ने उपभोक्ताओं को अब मोबाइल फोन पर ही बिलिंग की सुविधा उपलब्ध करा दी है। इसके तहत सबसे पहले गूगल प्ले स्टोर से पीएनजी मित्रा एप में डाउनलोड करें। कनेक्शन के बीपी नंबर और उपभोक्ता की ओर से लॉगिन के लिए बनाए गए पासवर्ड के जरिए लॉगिन करना होगा। गेल के मुख्य महाप्रबंधक विनय कुमार ने बताया कि इसके बाद डोमेस्टिक पीएनजी विकल्प में क्रमशः सेल्फ बिलिंग तथा वेरिफाई डिटेल्स भरनी होंगी।
