## BP Sees Growing Opportunities in India: CEO

New Delhi: Energy firm BP sees "growing business opportunities" in India, its global chief executive Murray Auchincloss said in a statement on Wednesday. The board of London-head quartered BP is holding a meeting in India this week, said a company statement.

This is the second time BP's board is meeting in India. The first meeting was held in 2013, about two years after company took a 30% interest

in Indian upstream projects managed by Reliance Industries for \$7.2 billion.

"We see growing business opportunities, including through our world-class partnership with Reliance, producing the country's gas and growing our joint retail presence. In turn, India's highly skilled engineering and scientific talent can help us deliver our targets more effectively, efficiently and rapidly," Auchincloss said.

He along with other board members met petroleum and natural gas minister Harde-



ep Puri on Tuesday. BP, in alliance with RIL, is engaged in natural gas produc-

tion and fuel retailing in India. BP and RIL partnered with state-run Oil and Natural Gas Corporation (ONGC) to bid for a western offshore block in the just-concluded exploration licensing round.

ONGC is also seeking to partner with a global oil firm

to help boost output from its flagship Mumbai High field which has producing for about half a century.

India is seeking to attract international firms to its exploration sector as they have access to big capital and advanced technologies which could come in handy to boost domestic output that's been falling for years. India's crude output has fallen by a fifth in the past decade.




## BP board meets in India for energy talks

he board of global energy giant BP plc is holding its meeting in India, reflecting the importance of the country and its confidence in the opportunities it presents, the firm said on Wednesday.

The board of BP began a fiveday visit on 23 September, holding board sub-committee meetings as well as meeting government leaders and business partners. In between, it will hold its full board meeting.

This is the second time that the board is holding its meeting in India. The firm's board had visited India in May 2013, two years after the firm spent \$7.2 billion in buying a 30% stake in 23 oil and gas blocks of Reliance Industries Ltd. Just like 2013, the BP board met oil minister Hardeep Singh Puri over dinner on Tuesday evening, flew to Gadimoga in Andhra Pradesh for a visit to the landing point of gas produced from deepsea in Krishna Godavari basin, and will meet partner Reliance Industries officials in

Mumbai. It will also visit the company's global business services centre in Pune.

Recognizing India's key role in global energy demand, during their visit the board will also hold meetings with the Indian government and BP's business partners, as well as visiting key bp India locations. The statement, however, did not elaborate on the meetings or the venue of the board meeting.

BP is one of the largest international energy firms in India, with a century-long business presence and having invested over \$12 billion across energy value chain in the country.



## Petrol and diesel prices may fall after 5 October: Report

Petrol and diesel prices may be reduced for the first time since March 2024 after October 5, according to CLSA.

The remarks came after the comments from India's Oil Secretary, Pankaj Jain, suggesting a price drop last month and media reports indicating that the Maharashtra's state elections are expected in early November.

CLSA notes that Maharashtra is a crucial battleground, and the BJP-led alliance may consider lowering fuel prices as a populist move.

Notably, the fuel prices have not changed since March 2024.

According to te media reports, Jain said that the state-run oil marketing companies (OMCs) may consider reducing petrol and diesel prices if international crude prices staylow for an extended period.

CLSA also believes that

the government may also raise excise duty on petrol and diesel, along with any retail fuel price cut. Excise duty is a type of indirect tax levied on the manufacture or production of goods within a country.

In the context of petrol and diesel, excise duty is a tax imposed by the central government on the production or sale of these fuels within India.

As per the brokerage, brent crude prices have cooled off below \$75 per barrel, despite OPEC's proactive steps to keep prices hike. CLSA notes that the government may opportunistically raise exciseduty.

The reports aid the sharp decline in crude oil prices is positive for Indian oil marketing companies like Indian Oil, Bharat Petroleum Corporation and Hindustan Petroleum Corporation.

However, apotential rate cut and excise duty hike make these oil marketing companies vulnerable.

Central government levies an excise duty of Rs 19.8 and Rs 15.8 per liter on petrol and diesel, respectively.

These duties stand 40 per cent and 50 per cent lower compared to their peak levels in 2021. This duty was last cut when oil prices were above \$100 per barrel.



# OPEC: India's oil demand to grow by 8 mb/d between 2023 and 2050

Oil demand in India, the world's third largest crude oil importer, is likely to grow by 8 million barrels per day (mb/d) between 2023 and 2050, which is the highest rate of growth globally, OPEC's World Oil Outlook (WOO) report reveals.


According to WOO 2050, oil demand in the world's fastest growing emerging economy is expected to grow from 5.3 mb/d in 2023 to 13.3 mb/d in 2050.

"Extending the outlook's time horizon to 2050 amplifies the role of India, other Asian nations, Africa and the Middle East as the key sources of incremental demand in the coming years," the report said.

"Combined demand in these four regions is set to increase by 22 mb/d between 2023 and 2050. India alone will add 8 mb/d to its oil demand during the forecast period. China's oil demand is projected to increase by 2.5 mb/d," it added.

#### DRIVING SECTORS

India's current oil demand composition is characterised by a relatively high share of diesel/gasoil, which accounts for around 35 per cent of the total demand. In fact, the share of diesel/gasoil is set to

expand to 38 per cent by 2040 before declining to 37 per cent in 2050, mainly due to expanding freight transport and industrial production. Some demand growth for this product also comes from the petrochemical industry, and the commercial and agriculture sectors. Accordingly, diesel demand is projected to increase by 3 mb/d from around 1.9 mb/d in 2023 to 4.9 mb/d in 2050.

OPEC's World Oil Outlook till 2050 projects that road transportation constitutes the primary key area where more than half of the overall demand increase is expected to materialise.

"This will be mainly driven by the significant expansion of the country's passenger car fleet, from less than 50 million in 2023 to more than 240 million in

2050 (excluding two-wheelers). Moreover, the number of commercial vehicles is set to more than quadruple during the period to 2050 on the back of strong GDP growth," it added.

Compressed natural gas (CNG) is fast becoming the fuel of choice for Indian car buyers, with sales growth of such passenger vehicles (PVs) in the first eight months of this year outpacing all

other variants.

Sales of CNG vehicles between January and August surged by 46 per cent year-on-year, whereas

that of petrol cars declined by 4.5 per cent; diesel model pickups grew by just 5 per cent.

The rise in CNG sales even outstripped that of petrol hybrid, diesel hybrid, and electric cars.

In volume terms, CNG vehicle sales are now roughly 30 per cent of petrol vehicle sales. One in every three cars produced by the country's largest automaker, Maruti Suzuki India (MSIL), is now a CNG model, with CNG penetration in the company's overall portfolio having reached 34 per cent as of August.

Several factors are driving this growth, from new car launches to an increase in CNG refuelling stations, as well as innovations like ata Motors' twin-

cylinder system. Original equipment manufacturers (OEMs) are also focusing on less polluting fuels to meet corporate average fuel efficiency (CAFÉ) norms, which aim to limit carbon dioxide emissions from car manufacturers in a financial year. Turn to Page 6

### Launches, more fuelling stations push CNG car demand

"The highest oil consumption and the highest CO2 emissions come from pure petrol and diesel vehicles. All other powertrain technologies — including electric, hybrid, CNG, and biofuel — help reduce oil consumption and CO2 emissions," explained Rahul Bharti, executive director of corporate affairs, MSIL. "It is both natural and desirable to minimise the use of pure petrol and diesel engines in favour of these technologies."

He further noted: "CNG is over 90 per cent methane (CH4), meaning it has four hydrogen atoms for every carbon atom, making it inherently clean (fuel)."

Ravi Bhatia, president and director of Jato Dynamics, noted a broader shift toward alternative fuels in India's auto market, as global electric vehicle (EV) growth shows signs of slowing. "Data from Jato Dynamics India highlights this trend, showing significant growth in (sales of) CNG (46 per cent) and hybrid vehicles (19 per cent) compared to EVs (7 per cent)," Bhatia said.

He attributed this shift to evolving consumer preferences and market realities. "CNG's affordability and practicality make it especially popular in the taxi



and small business segments, while hybrids are gaining ground among those seeking a balance between performance and efficiency."

For the first time, sales of CNG PVs in India surpassed diesel vehicles in the first quarter of this financial year. "This quarter, several new regions, including Rajasthan, Karnataka, Tamil Nadu, Madhya Pradesh, Kerala, and Bihar, are showing healthy growth in CNG adoption. Customer acceptance of CNG vehicles is on the rise, "Bharti told Business Standard last month.

In a sign of the growing momentum,

Tata Motors launched the Nexon iCNG, priced from 88.99 lakh, on Tuesday. Describing it as part of Tata's multipowertrain strategy, Vivek Srivatsa, chief commercial officer of Tata Passenger Electric Mobility, said: "The launch of the Nexon iCNG as India's first turbocharged CNG vehicle will attract customers who are value-driven and eco-conscious, but do not want to compromise on driving quality and experience."

The country's second-biggest carmaker Hyundai Motor India also introduced a dual-cylinder CNG variant of microduced a dual-cylinder CNG variant of priced at \$75.09 per kilogram.

its popular hatchback, the Grand i10 NIOS, last month, with prices starting at ₹7.75 lakh.

CNG options are now more frequently available in mid-range variants, rather than just entry-level models as was the case in the past, reflecting growing demand for personal use. As of now, there are 25 car models across various original equipment manufacturers (OEMs) offering CNG engines, up from 20 in June 2023 and just 13 a year earlier. The primary buyers remain commercial taxi and fleet operators, often due to regulations in many cities, as well as small business owners who use cars for trade. Industry insiders point out that CNG prices have remained relatively stable compared to petrol.

The increase in CNG vehicle sales is partly attributed to better fuelling infrastructure, with the number of stations growing from 3,180 in June 2021 to 6,959 in June 2024.

One major reason for petrol's decline against CNG, according to sector experts, is the price difference between the two fuels. Petrol currently costs \$94.72 per litre in Delhi, while CNG is priced at \$75.09 per kilogram.
